WHERE DO WE STAND IN KING COUNTY?


WHERE DO WE STAND IN KC?

- Despite 70% of King County being vaccinated across every racial group:
 - Hospitalizations have risen steeply.
 - There are an average of almost 600 new COVID cases daily.
 - And a 72% increase of cases in the last two weeks.
- The Washington State Hospital Association announced that Washington has never seen its hospital occupancy this high.
- Unvaccinated people are:
 - 67 times more likely to die from COVID-19 compared to those who are vaccinated (when adjusted for age),
 - $_{\circ}$ 6 times more likely to test positive for COVID-19,
 - 37 times more likely to be hospitalized after catching the disease.

COVID VACCINE RATES

3,041,749 doses administered to King County residents
as of 8/26/2021.

70% of King County being vaccinated across every racial group:



WHERE DO WE STAND IN KC?

- Masks are required for everyone, regardless of vaccination status, in public indoor spaces, and recommended in crowded outdoor settings.
- This helps protect everyone, including:
 - those that currently aren't able to be vaccinated,
 - those who are immune suppressed,
 - and those who have chosen not to get vaccinated.



SO WHAT DOES ALL OF THIS MEAN? DO THE VACCINES WORK?

YES. THE VACCINES WORK.

- Getting vaccinated is the best defense we have against COVID-19, including against the Delta variant strain.
- Being vaccinated makes it much less likely to catch and pass COVID-19.
- The vaccines are highly effective at preventing serious illness and hospitalization.



SO WHAT DOES ALL OF THIS MEAN? DO THE VACCINES WORK?

YES. THE VACCINES WORK.

Vaccinated people are:

- much less likely to catch and spread COVID-19, including the Delta Variant.
- much less likely to have severe symptoms if they do catch COVID.



The best way to protect yourself and your community is to get **fully vaccinated** — making sure to get both doses if you get Pfizer or Moderna.

YOUTH AND VACCINES



GETTING VACCINATED?

COVID vaccines are **FREE** and available to everyone 12 and older regardless of:

- insurance,
- citizenship,
- or immigration status.



GETTING VACCINATED?

12 – 17 year olds can get Pfizer

 It is 2 doses, 21 days apart

People 18 and older can get Moderna, Pfizer or Johnson & Johnson



GETTING VACCINATED?

A vaccine will probably be available for youth 11 and younger this fall, most likely after school has started.



GETTING VACCINATED: DO I NEED PARENT / ADULT CONSENT?

People 18 and under may need consent from an **authorized** adult.

If an authorized adult will NOT be with you when you get the vaccine, ask what you need to bring to the appointment with you to be able to get the vaccine.



These vaccine providers offer supportive environments for youth with disabilities. The providers are open to the public and serve minors. The staff are trained and/or comfortable serving youth with disabilities or youth who may need additional supports. This is not an all-inclusive provider list.
