When can I get a third dose from a King County vaccination site?


- King County's vaccination sites are ready to provide additional doses to eligible immunocompromised people.

- The benefits of in-person learning are tremendous, particularly for students who have felt the isolation strongly.
- School is key to healthy child and adolescent development.
- To reduce the risk from Delta to the greatest extent possible, we are recommending a "layered" approach – at school and at home and in the community.



Layered approach:

- Getting vaccinations for everyone who is eligible,
- Inside and outside of school, wear well-made and <u>snug-fitting masks</u>,
- Keep physical distance as much as possible,
- Get tested and stay home <u>when we have symptoms</u> (even mild ones) or are exposed to COVID-19,
- And improve indoor ventilation in K-12 schools and child care centers, remembering that outdoor activities are lower risk than indoors.

Outside of school, our entire community can support families with school-aged children. We can wear masks in indoor public settings, can get vaccinated and lime high-risk activities.

Masks should not be worn by:


- Those under 2 years of age.
- People with a medical condition, mental health condition, developmental or cognitive condition, or disability that prevents wearing a face covering. Including, people with a medical condition for whom wearing a face covering could obstruct breathing or who are unconscious, incapacitated, or otherwise unable to remove a face covering without assistance.



In these instances, students and staff may use a clear face covering or a face shield with a drape or wrap as an alternative to a cloth face covering.

Vaccination

- Vaccination is the most effective prevention strategy available for allowing schools to resume full-time inperson instruction.
- COVID-19 vaccines are available to all people age 12 and older. Schools should promote vaccinations for eligible students, teachers, staff, and families.
- K-12, child care and higher education staff in Washington state <u>are required</u> <u>by the State</u> to be fully vaccinated for COVID-19 by October 18.



Students need to <u>stay home</u> if anyone in their household **tests positive** or has been diagnosed with COVID-19.

And families should make sure students who have symptoms or who test positive stay home.

When outbreaks occur, Public Health works closely with schools to contain cases, investigates cases, advise those who have been exposed and make recommendations to districts on how to prevent or contain the outbreak.

In light of back-to-school and the more contagious Delta variant, Public Health is prioritizing additional resources to support schools in their efforts to prevent and contain outbreaks.

When an outbreak does occur, the final decision on closing a school lies with the school districts themselves. School administrators consider several factors whenever a case occurs including:

- How many people were exposed?
- Were those exposed wearing masks?
- If vaccine eligible, were those exposed vaccinated?
- When and where did those exposures occur?
- How many people need to isolate or quarantine?
- Do classes, practices or other school activities need to be canceled in order to contain the spread?

I lost my COVID-19 vaccination card.

What do I do?



- Sign up for MyIR (wa.MyIR.net)

 Look up your vaccination record, and then print or take a screenshot. If your records don't show up, call 833-VAX-HELP.
- Ask your provider

 If you received your vaccine at your health care provider, the provider's office should be able to give you a copy of your record.
- Ask at the vaccination site

 Go back to the site you were vaccinated and ask a clinic supervisor if they can look you up and create a new card.
